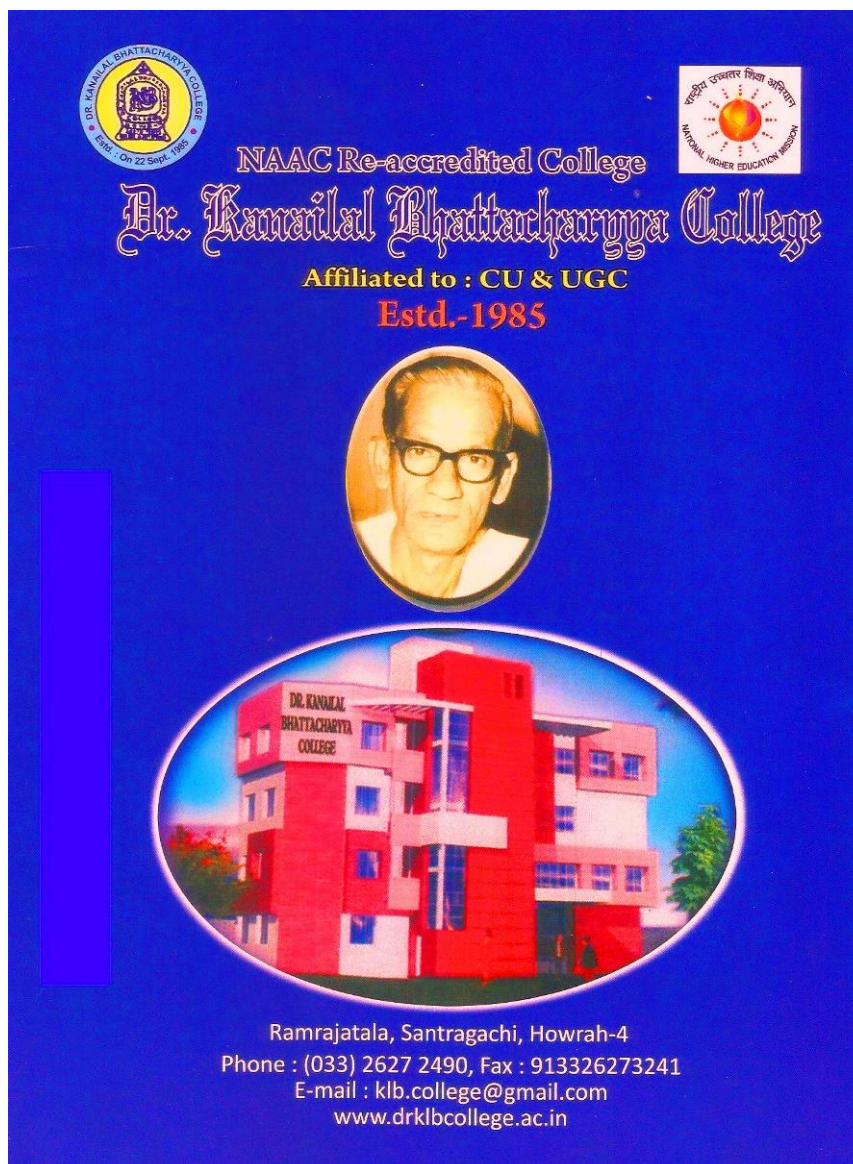

ANALYSIS OF FEEDBACK FROM STAKEHOLDERS

The students have given their feedback on teachers and college facility. They have given good feedback on an average about the teachers. However there are some instances where the students have noted shortcomings of some infrastructural facilities and well equipped digitized library. These points were brought to the IQAC meeting by the Principal. Permanent faculties are noted that we have to increase the number of computers available to the students and we require more computer lab and ICTs.

The parents in their feedback are happy about the college on an average. But they also have shown concern about the lack of permanent faculty. The parents and members of alumni association suggested introducing online feedback platform.

The Principal has brought these things to the notice of the Governing Body and Department of Higher Education, Government of West Bengal. It is expected that the management will take note of requirement of the college and necessary action will be taken.

BEST PRACTICE-I

1) TITLE OF THE PRACTICE:-

OPTIMIZATION OF FUNCTIONAL SKILL POTENTIALITY OF STUDENTS.

2) OBJECTIVES OF THE PRACTICE:-

Spatial hinterland of this college cohabits of both rural and urban domains in comparatively backward district of Howrah in West Bengal. The school education of the students is essentially steered by vernacular medium whereas any reputed study materials either in print version or e-platform are essentially in English language. Therefore the strategic prioritization is oriented to enable the students to overcome the language hurdle for getting access to contemporary enriched academic field in each subject.

3) THE CONTEXT:-

Strengthening the learning capacity of the students towards higher education by providing access the standardized English text book, ancillary books and other e-materials available through the internet browsing.

4) THE PRACTICE:-

Regular library work by the students consequent upon tasking them with home assignment is the first step to discern their level of weakness in the sphere of knowledge harvesting. Persistent rectification of assigned tasks can provide the students a preliminary level of confidence. Regular class tests and other stator examinations enable them to attain the desired skill and ability.

5) EVIDENCE OF SUCCESS:-

Constrained. Because University of Calcutta allows the students to write answer in vernacular medium. However in practical component such facility is unavailable. Therefore for the students pursuing science subjects this initiative becomes more fruitful.

6) PROBLEM ENCOUNTERED AND RESOURCES REQUIRED:-

UGC is required to remould its remedial coaching system with target specification, in the context of institutional constraints.

BEST PRACTICE-II

1) TITLED OF THE PRACTICE:- *SIGNIFICANCE OF THIS INSTITUTION AS TECHNICAL HUB.*

2) OBJECTIVES OF THE PRACTICE:-

The college is located within an industrial zone at Howrah district established during colonial period. So the rival of this industrial belt is one of the key important economic policies of the state West Bengal.

This college is located in this industrial belt. The NAAC Peer Team during its visit underlines the importance of this institution as a technical hub parallel to its mainstream curricular courses. Therefore by their recommendation UGC sponsored vocational course has been introduced. In this academic year 2016-2017 Tourism & Travel Management and Interior Decoration (UGC Vocational Course) as well as Automobile Mechanics Course both are remain functional. Side by side the IQAC has also started a preparation for GST training course for both ex-students, regular students and representatives of local industrial organizations.

3) THE CONTEXT:

The discussion of Government of India we are all aware that by Parliamentary Act. GST is going to be introduced by Govt. of India. Therefore the industrial companies in our surrounding deserve that our college should assist them to comply with this new GST Act. This has been transpired with regular interaction between the IQAC and industrial houses as our deemed stakeholder.

4) THE PRACTICE:-

The college arranged GST training seminars and we emphasis entire local industry as they are going to enter in to a new taxation system. We are also aware about the regular students. We have a Department of Commerce and Financial Management is included in their curriculum.

5) EVIDENCE OF SUCCESS:-

It is a foundation process and we are consulting with various organizations about our proposal. The IQAC has already organized a workshop on the said topic in collaboration with Institute of Computer Accounts (ICA), Kolkata. On the other hand our vocational students have successful career in the job oriented market.

6) PROBLEMS ENCOUNTERED AND RESOURCES REQUIRED:-

Recommendation of NAAC and financial assistance from UGC is required to run these courses more functional. Most of the students are below poverty line, so we collect nominal fund from them and for the interest of the students and local community we continuing these courses from our limited college fund.
