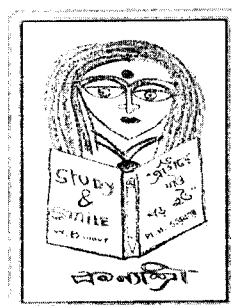
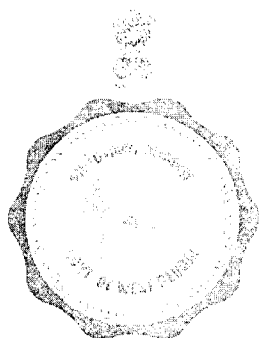

Vision

On the 1st of October 2013, Government of West Bengal launched Kanyashree Prakalpa for protecting and promoting the rights of girl children of West Bengal.

Kanyashree Prakalpa provides a safety net for those vulnerable families who are forced by tradition, social compulsion or poverty, to truncate the education of their daughters and contract them to wholly illegal and dangerous marriages. The scheme improves the status and wellbeing of girls, specifically those from socio-economically disadvantaged families, through Conditional Cash Transfers by:

- Incentivizing them to continue in education for a longer period of time, and complete secondary or higher secondary education, or equivalent in technical or vocational streams, thereby giving them a better footing in both the economic and social spheres.
- Disincentivising marriage till at least the age of 18, the legal age of marriage, thereby reducing the risks of early pregnancies, associated risks of maternal and child mortality, and other debilitating health conditions, including those of malnutrition.

Mission

The Scheme confers more than just monetary support; it is a means of financial inclusion and a tool of empowerment for adolescent girls. The scheme's benefits are therefore paid directly to bank accounts in the girls' names, leaving the decision of utilization of the money in their hands.

To reinforce the positive impact of increased education and delayed marriages, the scheme also works towards enhancing the social power and self-esteem of girls through a targeted behaviour change communication strategy. The communication strategy not only builds awareness of the scheme, but includes adolescent-friendly approaches like events, competitions and Kanyashree clubs, and the endorsement of strong women figures as role models to promote social and psychological empowerment.

Services Provided

It is a Conditional Cash Transfer Scheme and has two components:

K1- Annual Scholarship of Rs.1000/- (One thousand only)

K2-One time Grant of Rs.25, 000/- (Twenty Five Thousand only)

Girls will be eligible for Kanyashree's Annual Scholarship or the One-Time grant if they are studying in any one of the following institutions:

- 1) In Class VIII or above in a school, Madrassah or equivalent course.
- 2) In a college or Vocational Training Centre, Technical Training Centre or Industrial Training Centre

The educational institution MUST be registered in West Bengal AND recognized by the Government of West Bengal

Eligibility Criteria to get K1 money:

- Resident of West Bengal
- Between 13 and 18 years of age
- Unmarried
- Enrolled in classes VIII-XII in government recognised regular or equivalent open school or equivalent vocational/technical training course.

Eligibility Criteria to get K2 money:

- Resident of West Bengal
- Between 18 and 19 years of age
- Unmarried
- Enrolled in either of the institutions mentioned above.

For both K1 and K2 application, minimum Class VIII is waived if the girl is a child with special needs (disability 40% or more). In that case you have to submit a copy of the disability certificate with the application form.

Interface

Girls can collect the application forms from the institution they are studying in:

All schools/colleges/other institutions mentioned above registered with Kanyashree portal will get Kanyashree application forms from the nearest SDO/BDO office.

Type of applications:

Fresh K1: The application forms for the Annual Scholarship is called K1 and are printed on light green paper.

Fresh K2: The application form for the One-Time Grant is called K2 and are printed on light blue paper.

Renewal: Girls who have received K1 at least once and are still below 18 yrs fulfilling other conditions need not apply again for renewal of K1. The Head of the Institution shall verify the details and process the renewal application.

Up-Gradation: Girls who have received K1 and have crossed 18yrs now are eligible for K2. They have to collect pre-printed K2 Up-gradation form from the institution, fill it up and submit again.

Time line

Following the West Bengal Right to Public Services Act 2013, the time span between applications received and payment will be maximum 90 days.

Applicants' Information System

- Girls will get the following sms after submitting your Kanyashree application:
 1. After online submission of the form. At this stage Girls will also get to know their Kanyashree ID.
 2. When their application is transferred out from their previous institution.
 3. When their application is transferred into their present (new) institution.
 4. When their application is sanctioned.
 5. If their application is rejected.
- They can track your Kanyashree status from portal through the link
- They can submit online grievance in the portal thorough the link
- If anything goes wrong and Girls do not receive any of the sms or grant in their bank account, they have to get in touch with the Nodal person of Kanyashree of the institution.
- The nodal teacher of institutions will try to solve the problems of the Kanyashree applicants of their institutions and will communicate with block/district/state authority as required on their behalf.
- Girls can also contact the District Project Manager, Kanyashree of the concerned district. The list of District and State Nodal officers with their contact details are available at the “Nodal Officer” tab in the Home Page.

Video Conference

Sir,

As mentioned in the VC held with Kanyashree DPMUs on 9th January 2018, KP Years 2015-16 and 2016-17 will be brought to a complete closure by the following dates: 31st January 2018 for 2015-16, and 10th March 2018 for 2016-17. In this connection, please note the following:

1. Districts' Action plan for phased closure of the KP Year 2015-16 is as follows:

Cases sanctioned on the day of closing of 2015-16 i.e., 31.01.2018 will appear in 2016-17 by 02.02.2018. b. All processes at BDO and DPMU level will follow the normal course of action, including K2 physical verification and PFMS verification. c. 3. The following issues will be resolved by SPMU and NIC and communicated to districts ASAP:


- a. AADHAAR related issues
 - b. Cases pending at PFMS for facilitating sanction and payment
4. All districts are to make special effort to ensure that all eligible K2 girls who are enrolled but not yet sanctioned are individually identified and their applications processed in both 2015-16 and 2016-17 (barring fresh entries and incomplete uploads in 2015-16), and sufficient documentation exists to justify the exclusion of un-identified / excluded K2 beneficiaries. In addition, districts should ensure that all K2 girls are provided Kanyashree certificates to ensure that those who wish to apply for the Swami Vivekananda Merit-cum-Means Scholarship for Post-Graduate Studies (K3) have the necessary documentation to facilitate the process.
5. Districts are advised to have immediate and intensive consultations with HOIs to ensure that processing at their level is completed in a timely manner and ensure complete inclusion of all eligible girls.
6. There will be no further extensions to the abovementioned closing dates at any processing level.

7. Other issues that affect all districts:

- a. All districts are to mark non responsive educational institutions at their log in and also to send report to SPMU by 15th of January 2018.
- b. IFMS issues:
 - i. SPMU and NIC have taken up all technical issues with the IFMS team, and will revert to districts shortly.
 - ii. An IFMS workshop with all the districts will be held by on 19th January 2018 at the state-level. Please proceed accordingly.

Sub: Update on Bangla Shiksha – Kanyashree Portals Integration (KP Year 2022-23)

Sir/Madam,

Based on the data dump received from the School Education Department, all girl students between the ages of 13 and 18 years in Class VIII were imported into the KP Portal from the BS Portal. An extensive de-duplication exercise was undertaken by schools, and all girls found to be eligible vis-à-vis the eligibility criteria of Kanyashree Prakalpa are currently being processed as Fresh (First-time) K1 beneficiaries for the Kanyashree Year 2022-23.


An API is being developed by this Department to include other possible fresh K1 beneficiaries from the BS Portal for the Kanyashree Year 2022-23; these are:

- a. Girls between the ages of 13 to 18 years and in Class VIII who were not in the BS database as on ;17th May 2022
- b. Girls between the ages of 13-18 years in Classes IX to Class XII.

The API is expected to be in operation in November.

In the meantime, all districts are requested to sensitize HOIs and nodal teachers of the need for 100% correct student data in the BS data-base before the API is deployed. Once a potential Kanyashree beneficiary's data is imported into the KP database, the Kanyashree Prakalpa portal will not allow corrections of critical fields, viz. Name of beneficiary, date of birth and class. This is to ensure sanctity of the Kanyashree database that disburses a substantial sum of funds each year to beneficiaries via a stringent verification process.

It must therefore be made clear to all schools that if a beneficiary's name, age or class is erroneous at time of import from the BS portal to the KP Portal, necessary corrections must be made before importing such data as subsequently corrected data will not be allowed to be imported into Kanyashree Prakalpa Portal. All schools may be advised to prioritize correcting erroneous data of the above-mentioned potential Kanyashree beneficiaries by November 2022.



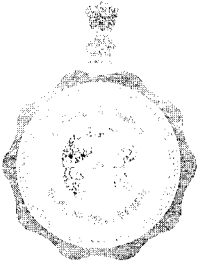

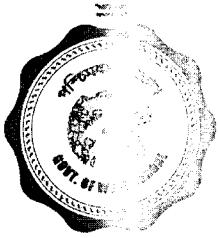

- Students pursuing higher secondary, ITI, Diploma, Graduation, Post Graduation, M.Phil, B.Ed. etc. from recognised institutions in West Bengal
- Annual family income of the applicant should not exceed ₹2 lakhs
- Scholarship amount maximum upto ₹16,500 p.a, subject to actuals



- Students domiciled in West Bengal and pursuing undergraduate/postgraduate/professional/technical courses in recognised institutions in West Bengal, affiliated to any recognised university. However, students domiciled in West Bengal and pursuing their courses in any of the listed institutions only like IIT, IIM, NIT, NIFT, IIIT, etc. in or outside West Bengal are also eligible.
- Annual family income of the applicant should not exceed ₹2.5 lakhs
- Scholarship amount maximum upto ₹3,000/- p.a., subjects to actuals
- Students of the listed institute will get reimbursement of tuition fee(as per list of institutes available at www.wbmdfcscholarship.in)

IMPORTANT INSTRUCTIONS

- Candidates domiciled in West Bengal only are eligible to apply.
- The students must have passed last examination with at least 50% marks (except for Class I)
- A student is eligible for a scholarship from any one source only
- One mobile number can be used for the registration of one application only. However, in case of pre-Matric Scholarship, a maximum of four applications can be filled through one mobile number.
- After submitting the online application, the student must take a print-out of the same and submit it to the concerned institute, along with a photocopy of bank passbook containing bank account no. and IFSC code
