

#### GRIEVANCE REDRESSAL CELL

- The Cell after verifying the facts will try to redress the grievance within a reasonable time, preferably within a month of the receipt of application of the student. While dealing with the complaint the committee will observe law of natural justice and hear the complainant and concerned people, as and when required.
- 4. The Cell may recommend to any necessary corrective action as it may deem fit, to endure avoidance of recurrence of similar grievance in future. 


