

Limited having its registered office at Block BN, Plot-7, Sector-V, Salt Lake, Kolkata - 700091, West Bengal (herein called TCGLS which shall include its subsidiary companies as well as affiliates companies in lifesciences, incorporated by promoters of TCGLS) on the other part.

PREAMBLE

Whereas the DRKLBCOLLEGE has the objective to provide facilities and promote studies in emerging areas of under graduate education on the frontiers of biological science. In pursuance of the objective, the college has been endeavoring to develop closer relationship with the corporate world so that the synergy between academics and business world can be reaped to the fullest extent.

Whereas TCGLS, a leading company engaged in contract research services and informatics providing services to global pharmaceutical and biotechnology companies in the area of drug discovery & development as well as involved in basic research. The company presently has more than 750 scientists (including approx 150 PhDs), operating from Kolkata, Hyderabad USA and Europe.

NOW, THEREFORE, IT IS HEAREBY AGREED TO BY AND BETWEEN DRIKLBCOLLEGE AND TCGLS AS FOLLOWS:

1 SCOPE OF MOU

This MoU supersedes all previous correspondence and discussion and understanding taken place between the two parties pertaining to this MoU.

PERIOD OF MoU

This MoU comes into effect from the date of its signing and will remain in force for a period of 2(two) years on renewal basis based upon mutual interest.

SCOPE OF THE WORK

The details of the agreements are as given below:

- a) DRKLBCOLLEGE will organize a one day study tour for the UG students of DRKLBCOLLEGE for the Botany, Physiology, Zoology streams to an extent of a maximum no of 9 in the premises of TCGLS twice in a year.
- The selection of the students will be done by DRKLBCOLLEGE based on merit.
- c) The expenses of the tour shall be borne by DRKLBCOLLEGE.

- d) The students will receive a certificate after the end of the day.
- e) DRKLBCOLLEGE and TCGLS will nominate one coordinator ("Coordinator") from the respective Institutions to plan and execute the activities below.
- f) TCGLS will provide an opportunity to the students and faculty members of DRKLBCOLLEGE to visit the premises of TCGLS which will involve a lab tour with live demonstration of experiment followed by career orientation discussion.
- g) This tour will be organized twice in a year. The first visit will be in the month of June and second visit will be in month of December. The Coordinators will decide the exact dates at mutual convenience.

4. Termination

Either party can terminate the collaboration by issuing a termination notice to the other party. The notice period will be 2 months.

Arbitration

In the event of any question, dispute or difference whatsoever arising between the parties to this Agreement out of or relating to the construction, meaning scope, operation or effect of this Agreement or the validity of the branch thereof shall be referred to Arbitration wherein Principal of DRKLBGOLLEGE and Head HR - TCGLS will constitute the arbitration bench.

6. Governing Law
